Spotted 150 gals 7-1/2% HCL acid at 2625'. Pulled tbg & bit. Perf w/2 JSPF Granite Wash intervals 2560'-74', 77'-82', 90'-94', 2598'-2604', 2608'-10', and 13'-23'. Ran tbg & pkr to 2528'. Acidized w/2000 gals 7-1/2% HCL w/90 ball sealers. Ran gamma ray & temp survey. Swabbed 40 hrs & recovered 97 BLW. Released pkr. Ran tbg & pkr to 2540'. Spotted w/100 gals 7-1/2% HCL acid & flushed tbg w/10 bbls. Pulled tbg & pkr. Ran 3-1/8" csg gun w/2 JSPF. Perf 2508'-36'. Ran tbg & pkr to 2540'.
