Moved in completion unit 12-1-81. Perforated 2117'-42' with 2 SPF. Acidized with 1200 gal 7-1/2% HCL. Perforated 2217'-32' with 2 JSPF. Acidized with 17 bbl 7-1/2% HCL. Perforated 2155'-70' with 2 JSPF. Set a retrievable bridge plug at 2203' and a packer at 2150'. Acidized with 850 gal 7-1/2% HCL acid. Pulled the retrievable bridge plug and packer. Fractured with 15000 gal gelled, x-linked 2% KCL water with additives and 13500# 8/12 sand. On 12-22-81 turned thru a separator and flow tested for 168 hrs. at an average of 1046 MCFD. Ran 72 hr. BHP buildup test on 12-29-81. Pulled BHP bomb on 1-1-82. Well shut-in 1-1-82.
