Drilled to a TD of 2150' and ran 7" 23# & 26# casing set at 2150'. Cemented with 600 sx Class C cement with 9-1/2# NACL/sx and 1/4# Celloflake/sx and 3% KCL. Plug down 2:30 AM 6-20-79. Lost circulation while mixing cement. Temp survey found top of cement at approx. 870' from surface. WOC 18 hrs. Tested casing with 1000# for 30 min. OK. Core #1 2150'-2205'. Recovered 30'. Core #2 2205'-2237'. Recovered 30'. Core #3 2237'-2244'. Recovered 7'. Drilled to a TD of 2407'. Currently waiting on service unit.
