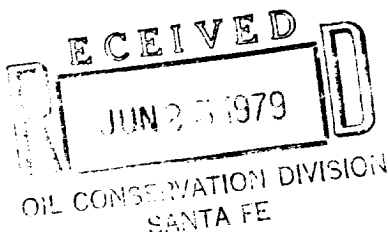

Circulated 20 SX. Plug down 8:30 AM 6-16-79. WOC 18 hrs. Tested casing with 1000# for 30 min. OK. Reduced hole to 8 3/4" and resumed drilling.
