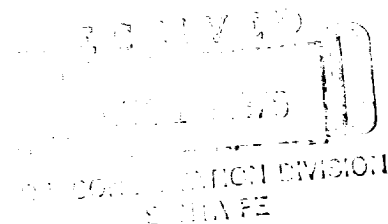

On 7-20-79 Baker & Taylor Drilling Co. (Rig #16) spudded a 12-1/4" hole at 1:30 p.m. Drilled to a TD of 363' and ran 8-5/8" 24# casing set at 363'. Cemented with 200 SX Class C cement with 2% CACL. Plug down 12:30 a.m. 7-21-79. Circulated 32 SX. WOC 18 hrs. Tested casing with 1000# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling.
