Will complete per the following procedure:
Run bottom hole pressure test. Pull tubing. Run and set a retrievable bridge plug at 2590'. Perforate Tubb 2470' - 74', 2477' - 81', 2486' - 98', 2504' - 08', 2511' - 34', 2540' - 69' with 2 JSPF. Acidize with 4000 gal Western's A-20.2 acid. Swab back load. Flow test up to 7 day limit to stabilize production. Run 72 hr. Bottom Hole Pressure test. Will evaluate possibility of fracture stimulation after BHP results.
