On 7-10-79 Baker and Taylor Drilling Co. (Rig #16) spudded a 12-1/4" hole at 12:00 noon. Drilled to a TD of 370' and ran 8-5/8" 24# casing set at 368'. Cemented with 200 SX Class C cement with 2% CACL. Plug down 10:00 p.m. 7-29-79. Circulated 5 SX. WOC 22 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling.
