On 1-5-81 Aztec Drilling (Rig #50) spudded a 12-1/4" hole at 2:30 p.m. Drilled to a TD of 707' and ran 8-5/8" casing set at 707'. Cemented with 500 SX Class H cement. Plugged down 10:15 a.m. 1-6-81. Circulated 50 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2315' and ran 5-1/2" casing set at 2315'. Cemented with 620 SX Class H cement. Plugged down 6:30 p.m. 1-11-81. Circulated 220 SX. Currently waiting on completion unit.
