Moved in service unit 10-5-81. Pulled tubing. Ran packer and tubing. Set packer at 2000'. Fractured with 7000 gal. pad and 2100 gal. 7-1/2% HCL acid with 1 lb. per gal. 8/12 sand. Pumped 1932 gal. pad and 2100 gal. 7-1/2% HCL acid with 1 lb. per gal 8/12 sand, and 6300 gal. 7-1/2% HCL acid with 2 lb. per gal. 8/12 sand. Flushed with 1000 gal. water. Moved out service unit 10-12-81. Flow tested for 168 hrs. and flowed 9456 MCF and 12 BLW with an average of 1351 MCFD. Ran 72 hr. BHP buildup test 10-19-81 thru 10-22-81. Moved in service unit 11-12-81. Pulled 2-7/8" tubing. Ran 2-3/8" tubing with seating nipple landing at 2164'. Moved out service unit 11-13-81. Well shut-in 11-13-81.
