On 4-5-81 Aztec Drilling (Rig #56) spudded a 12-1/4" hole at 4:30 a.m. Drilled to a TD of 727' and ran 8-5/8" casing set at 727'. Cemented with 500 SX Class H cement. Plugged down 5:00 p.m. 4-6-81. Circulated 190 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2321' and ran 5-1/2" casing set at 2321'. Cemented with 825 SX Class H cement. Plugged down 5:15 a.m. 4-11-81. Circulated 225 SX. Currently waiting on completion unit.
