On 3-23-81 Calvert Western (Rig #5) spudded a 12-1/4" hole at 3:00 a.m. Drilled to a TD of 706' and ran 8-5/8" casing set at 706'. Cemented with 500 SX Class H cement. Plugged down 5:30 a.m. 3-25-81. Circulated 176 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2411' and ran 5-1/2" casing set at 2411'. Cemented with 800 SX Class H cement. Plugged down 2:00 a.m. 3-30-81. Circulated 220 SX. Currently waiting on completion unit.
