On 2-26-81 CRC Colorado (Rig #66) spudded a 12-1/4" hole at 3:30 a.m. Drilled to a TD of 715' and ran 8-5/8" casing set at 712'. Cemented with 500 SX Class H cement. Plugged down 4:15 p.m. 2-27-81. Circulated 42 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2290' and ran 5-1/2" casing set at 2289'. Cemented with 1000 SX Class H cement. Plugged down 8:10 p.m. 3-7-81. Circulated 200 SX. Currently waiting on completion unit.
