On 3-4-81 James Drilling (Rig #7) spudded a 12-1/4" hole at 12:01 p.m. Drilled to a TD of 700' and ran 8-5/8" casing set at 700'. Cemented with 500 SX Class H cement. Plugged down 11:30 p.m. 3-5-81. Circulated 120 SX. WOC 18 hrs. Tested casing with 800# for 1 hr. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2250' and ran 5-1/2" casing set at 2250'. Cemented with 675 SX Class H cement. Plugged down 2:40 p.m. 3-12-81. Circulated 200 SX. Currently waiting on completion unit.
