On 3-9-81 CO2 in Action (Rig #19) spudded a 12-1/4" hole at 6:00 p.m. Drilled to a TD of 691' and ran 8-5/8" casing set at 691. Cemented with 500 SX Class H cement. Plugged down 12:15 p.m. 3-12-81. Circulated 50 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2300' and ran 5-1/2" casing set at 2300'. Cemented with 700 SX Class H cement. Plugged down 8:30 a.m. 3-18-81. Circulated 225 SX. Currently waiting on completion unit.
