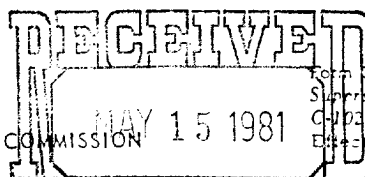

1. MIRU pulling unit and set a CIBP @ approx. 650' and dump 4 sacks of cement on top of CIBP @ 650-600'.
2. Set a 10 sack cement surface plug a 50-0', remove well head, clean location and install a 4" dry hole marker to designate a plugged and abandoned location.
