On 3-24-81 Royal Drilling (Rig #1)spudded a 12-1/4" hole at 10:00 p.m. Drilled to a TD of 725' and ran 8-5/8" casing set at 725'. Cemented with 500 SX Class H cement. Plugged down 12:30 a.m. 3-26-81. Circulated 110 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2590' and ran 5-1/2" casing set at 2590'. Cemented with 570 SX Class H cement. Plugged down 12:30 p.m. 3-30-81. Circulated 230 SX. Currently waiting on completion unit.
