On 4-19-81 Salizar Rig #13 spudded a 12-1/4" hole at 12:01 p.m. Drilled to a TD of 703' and ran 8-5/8" casing set at 700'. Cemented with 500 SX Class H cement. Plugged down 7:00 p.m. 4-21-81. Circulated 120 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2540' and ran 5-1/2" casing set at 2540'. Cemented with 800 SX Class H cement. Plugged down 7:00 p.m. 4-27-81. Circulated 260 SX. Currently waiting on completion unit.
