On 4-29-81 T & R Drilling (Rig #1) spudded a 12-1/4" hole at 1:15 a.m. Drilled to a TD of 712' and ran 8-5/8" casing set at 712'. Cemented with 425 SX Class H cement. Plugged down 12:30 p.m. 4-10-81. Circulated 100 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2269' and ran 5-1/2" casing set at 2269'. Ran DV tool to 1102'. Cemented first stage with 500 SX Class H. Plugged down 3:00 p.m. 4-24-81. Cemented second stage with 1000 SX Class H cement. Plugged down 4:30 p.m. 4-24-81. Did not circulate cement.
