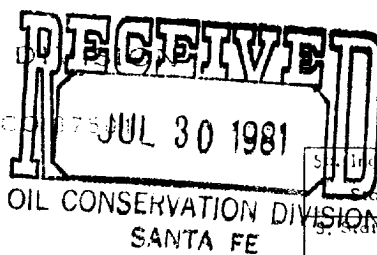

Moved in service unit 7-13-81. Ran an set bridge plug at 1943'. Ran pipe recovery log and found top of cement at 898'. Perforated casing at 878' with 4 JSPF. Cement squeezed with 250 SX Class H. Circulated 30 SX. Ran bit and tagged cement at 753'. Drilled out cement from 753'-890'. Pressure tested casing to 800 psi for 30 min. Held OK. Swabbed well. Well shut-in 7-26-81.
