Propose to plug and abandon as follows:

Drill out cast iron bridge plug at 1949'. Set a cast iron bridge plug at apx. 2670'. Pump 35 bbl heavy mud. Spot 25 sacks class H cement on top of cast iron bridge plug. Spot 25 sacks class H cement from apx. 1150' to 1340'. Circulate hole with clean water. Fill pits, level location, and clear area of junk. Remove wellhead and turn well over to rancher. (See attached affidavit of responsibility.)
