On 8-15-83 Aztec Drilling (Rig #56) spudded a 12-1/4" hole at 10:45 pm. Drilled to 720' and 9-5/8" casing set. Cement 375 sacks class H and additives. Plugged down at 8:30 pm 8-16-83. Circulated 227 sacks to pit. Test casing at 600 psi for 30 min. and OK. Weld on surf head. Log to 1110". Pumped 300 bbls of mud and no returns. Cleaned out fill from 2573' to 2618'. Ran 7" casing and set at 2618'. Wash, circulate and pump 50 bbl mud. Pump 800 sacks cement and circulate. Plugged down at 2:20 am. 8-23-83. Ran temp survey and rig released 8-23-83. Currently waiting on completion unit.
