On 9-1-83 C02 in Action (Rig No. 18) spudded a 12-1/4" hole at 12:30 pm. Drilled to 720' and set 9-5/8" casing. Cemented with 375 sacks class H and additives. Plugged down at 2:45 am on 9-2-83. Circulated 125 sacks cement to pit. Tested casing at 600 psi. for 30 min. and OK. Logged and ran 7" casing and set at 2719'. Cemented with 1100 sacks class H and additives. Plugged down at 8:30 pm. on 9-6-83. Circulated 360 sacks cement to pit. Rig released at 10:30 pm. on 9-6-83. Currently waiting on completion unit.
