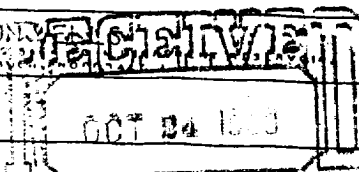

Circulated 120 sacks cement to reserve. Tested casing and 600 psi for 30 min and OK. Logged and ran 7" casing set at 2628'. Cemented with 800 sacks Class H and additives. Circulated 250 sacks and plugged down at 10:00 pm on 9-23-83. Rig released at 12:30 pm on 9-24-83. Currently waiting on completion unit.
