On 9-19-83 CO₂-In-Action (Rig # 18) spudded a 12 1/4" hole at 5:30 pm. Drilled to 693' and set 9 5/8" casing. Cemented with 375 sacks class H cement & additives. Plugged down at 1:00 am on 9-21-83 and circulated 105 sacks cement to reserve. Tested casing for 30 min. at 600 psi and OK. Logged and ran 7" casing and set at 2725'. Cemented with 1150 sacks class H & additives. Plugged down at 3:15 pm on 9-26-83. Circulated 403 sacks cement to pit. Rig released at 5:30 pm on 9-26-83. Currently waiting on completion unit.
