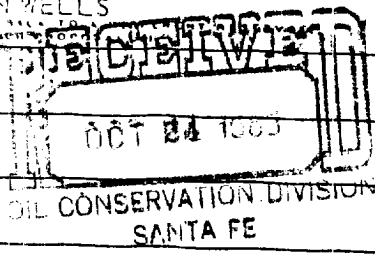

Plugged down at 6:00 am on 9-25-83 and circulated 78 sacks to reserve. Tested casing at 600 psi for 30 min and OK. Logged and ran 7" casing & set at 2638'. Cemented with 650 sacks Class H and additives. Plugged down at 1:00 am on 9-30-83. Did not circulate cement. Rig released at 3:00 am on 9-30-83. Currently waiting on completion unit.
