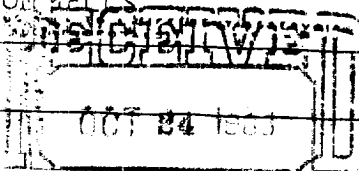

On 9-30-83 Aztec Drilling Co. (Rig #56) spudded a 12-1/4" hole at 2:00 pm. Drilled to 722' and set 9-5/8" casing. Cemented with 375 sacks Class H & 2% CACL. Plugged down at 4:30 am on 10-1-83 and circulated 125 sacks to reserve. Tested casing at 600 psi for 30 min. & OK. Logged and ran 7" casing and set at 2713'. Cemented with 700 sacks Class H & additives. Circulated 230 sacks to reserve pit. Plugged down at 11:45 pm on 10-4-83. Tested casing at 1100 psi for 30 min & OK. Rig released on 10-5-83 at 1:45 am. Currently waiting on completion unit.
