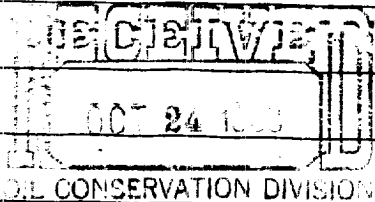

On 10/14/83 Aztec Drilling Co. (Rig #56) spudded a 12-1/4" hole at 11:30 p.m. Drilled to 723' and set 9-5/8" casing. Cemented with 390 sacks Class H and additives. Circulated 153 sacks to reserve. Plugged down at 3:45 p.m. on 10/15/83. Tested casing at 600 psi for 30 min. and ok. Logged and ran 7" casing and set at 2570'. Pumped 600 sacks Class H and additives. Circulated 162 sacks cement and plugged down at 10:45 on 10/18/83. Tested casing at 1000 lbs. for 30 min. and ok. Rig released at 1:00 a.m. on 10-19-83. Currently waiting on completion unit.
