Plugged down at 9:15 a.m. on 10/4/83 and circulated 114 sacks cement. Tested casing for 30 min. and ok. Logged and ran 7" casing and set at 2829'. Cemented with 1100 sacks Class H and additives. Plugged down at 2:4 p.m. on 10/8/83. Circulated 320 sacks cement to reserve. Rig released at 5:00 p.m. on 10/8/83. Currently waiting on completion unit.
