On 10/5/83 Aztec Drilling Co. (Rig #56) spudded a 12-1/4" hole at 5:45 p.m. Drilled to 725' and set 9-5/8" casing. Cemented with 375 sacks Class H cement. Circulated 190 sacks and plugged down at 9:30 a.m. on 10/6/83. Tested casing at 600 psi for 30 min. and ok. Logged and ran 7" casing and set at 2825'. Cemented with 700 sacks Class H and additives. Circulated 166 sacks and plugged down at 1:24 p.m. on 10/9/83. Rig released at 5:00 p.m. on 10/9/83. Currently waiting on completion unit.
