Propose to MIRUSU and kill well with 2% KCLW. Release pkr and POH tbg and pkr. RIH with bit and tbg to clean out casing. POH tbg and bit. RIH with 4" hollow carrier casing gun and perf 2268-2353 and 2356-2372' with 2 SPF 90 degree phasing. RIH with pkr and tbg and set pkr. Pump annular volume of 2% KCL inhibited water down backside. Swab well to kick off flowing and allow well to clean up. Stim with 21 tons liquid CO2 and flow tst overnight. Return well to production.
