On 10-13-83 CO₂-In-Action (Rig #18) spudded a 12 1/4" hole at 5:15 pm. Drilled to 720' & set 5/8" casing. Cemented with 390 sacks class H & additives. Plugged down at 7:20 am on 10-14-83. Circulated 280 sacks cement to pit. Tested casing at 600 psi for 30 min. & OK. Logged & ran 7" casing and set at 2635'. Cemented with 1000 sacks class H cement & additives. Circulated 317 sacks cement to pit. Plugged down at 10:30 am on 10-19-83. Tested casing at 500 psi for 30 min & OK. Rig released at 1:00 pm on 10-19-83. Currently waiting on completion unit.
