Plugged down at 11:45 a.m. on 10-9-83 and circulated 152 sacks to reserve. Tested casing and OK. Logged and ran 7" casing and set at 2645'. Cemented with 800 sacks Class H & additives. Plugged down at 9:45 on 10-13-83. Circulated 279 sacks cement. Tested casing at 1500 psi for 30 min. and OK. Rig released at 11:45 a.m. on 10-13-83. Currently waiting on completion unit.
