On 11-6-84 Aztec Rig 56 spudded a 12 1/4" hole and drilled to 705 ft. Ran and set 9-5/8 casing at 709 ft. Cemented with 390 sacks Class H cement with additives. Plugged down at 7:00pm on 11-7-84. Circulated 207 sacks to reserve pit. Wait on cement for 12 hours. On 11-12-84 ran and set 7" casing at 2492 ft. Cemented with 500 sacks Class H cement with additives. Plugged down at 11:00 pm. Circulated 112 sacks cement to reserve pit. Rig Released at 2:00am on 11-12-84.
