On 11-4-84 CO2 in Action Rig, 16 spudded a 12 1/4" hole. Drilled to a total depth of 734 ft and set 9-5/8" casing. Cemented with 390 sacks Class H cement with additives. Plugged down at 8:52 pm on 11-9-84. Wait on cement for 12 hours. On 11-15-84 ran 7" casing and set at 2988 ft. Cemented with 840 sacks Class H cement with additives. Circulated 55 sacks Class H cement to reserve pit. Plugged down at 12:45am on 11-15-84. Rig released 3:45 am on 11-15-84.
