Purpose: To eliminate pressure on the casing - tubing annulus.
1. MI Service Co. Pmp 20 Bbls of 2% KCL Fresh water @ 1-2 BPM to establish an injection rate and pressure.
2. Pmp 45 Sx 11" C" neat cement down Tbg @ 1-2 BPM & flush to bottom of Tbg or until sqz pressure of 1000 psi is obtained. Leave well shut-in over night. RBMO Service Co.
3. Bleed any pressure of Tbg & Csg annulus & check for pressure build-up in one month.
