On October 26, 1984 Aztec Rig #56 spudded a 12 1/4" hole. Drilling to a total depth of 722' and set 9 5/8" casing. Cemented with 390 sacks class H cement with additives. Plugged down at 9:00 AM on 10-27-84. Circulated 98 sacks cement to reserve pit. Wait on cement for 12 hours. Ran 7" casing and set at 2760'. Cemented with 650 sacks class H cement with additives. Plugged down at 7:00 PM on 10-30-84. Circulated 110 sacks cement to reserve pit. Rig released 10:00 PM on 10-30-84.
