Perforated 2395-2429', 2434-98', 2501-07', 2513-22', 2526-38', 2543-48', 2555-63', 2566-71', 2575-85', 2603-24' with 4 JSF. Killed well with 95 BW 290 KCl. RIH with production tubing and packer. Tailpipe landed at 2256' and packer set at 2225'. Stimulated with 25 Tons CO₂ and 672 ball sealers. MOSU 11-1-85 and flow tested 92 hrs. Last 24 hrs flowed 3619 MCFD and 1 BBL. Shut-in well.
