AZTEC Rig No. 56 spud the subject well with a 12 1/4" bit on 11-13-85. Drilled to a TD of 704'. Ran 9 7/8" casing and set at 704'. Cemented with 3905X class H with 2% CACL2. Circulated 705X to pit. WOC. Pressure tested casing to 1200 psi for 30 mins - ok. Reduced bit to 8 3/4" and drilled to a TD of 2736'. Ran 7" casing and set at 2736'. Cemented with 6005X class H cement. Circulated 1585X to pit. Rig released 5:00pm 11-18-85. No further report until MICU.
