TRANSCRIPT OF FIELD NOTES OF SURVEY OF
WELL SITES FOR KELLY, MOORE & RADER

October 3 1955

Clear & Warm.

Party, D. S. Durrin, Inst.

K. E. Rader, Head Chain.

Location of well site in center of NE $\frac{1}{4}$ NW $\frac{1}{4}$ Section 27. T 20N. R26E.
N.M.M.

To be known as Foster No. 1

Began at "A" the half section line (1300) marked by fences extending North and south on both sides of the East & West graded road. There was no U.S. survey $\frac{1}{2}$ corner rock found here. Ran West from this mark point to center of the north side of the Northeast Quarter of the Northwest of Section 27, Township 20 N. Range 26E. N.M.M. 660 feet Mag. Decl 13 deg. 30 min East. With instrument at this point ran South 660 feet, same decl and set stake for center NE $\frac{1}{4}$ NW $\frac{1}{4}$ Sec 27.

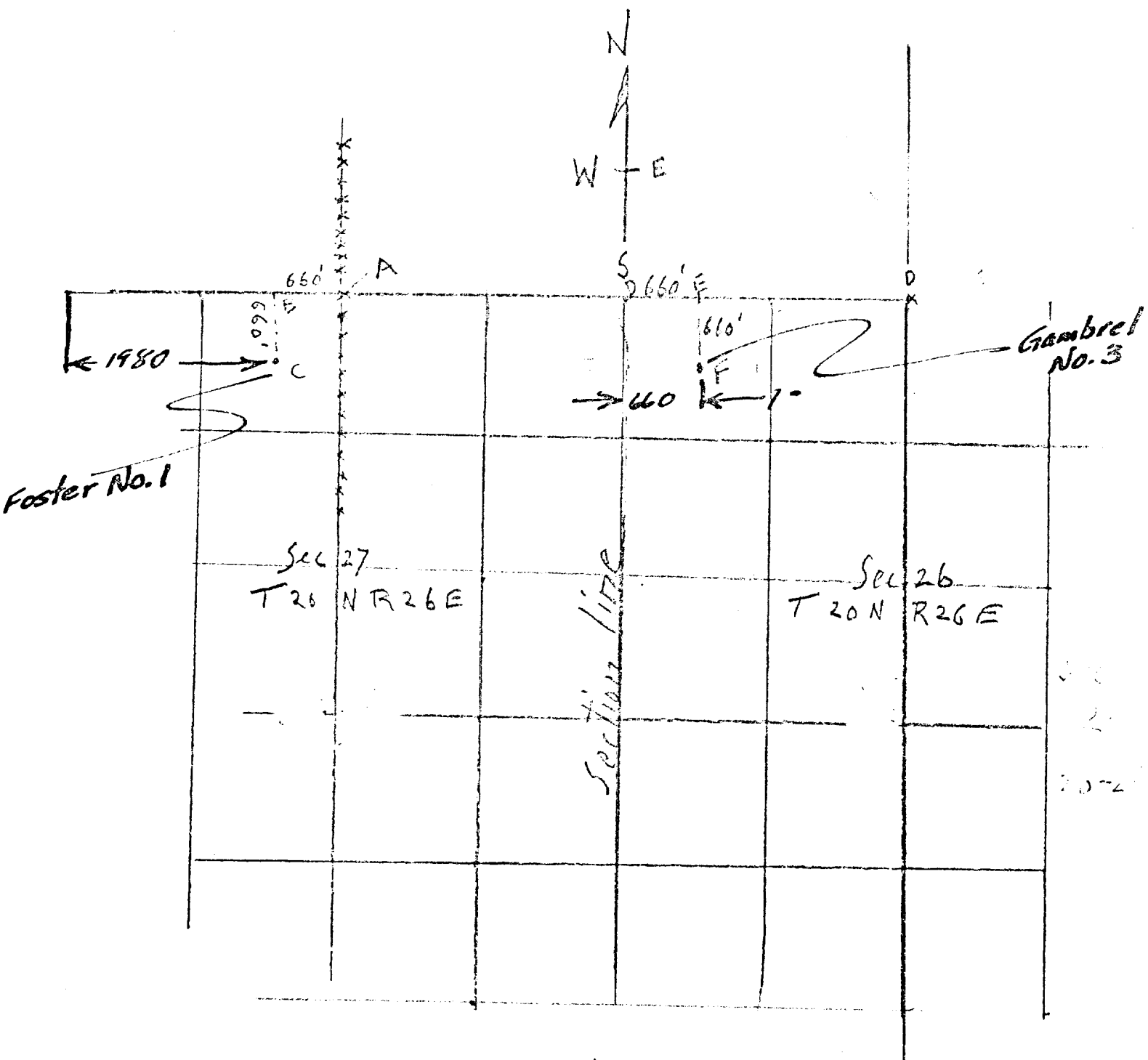
Same date & Party; Location of well site in center of NW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 26, Twp 20 N. Range 26 E. N.M.M. Harding County N.M.

Began at section corner common to sections 22, 25, 26 & 27, old established roads both East-west and North-south here. Ran East 660 feet decl 13 deg, 30 min E. to point (the section corner marked "D" on sketch) "E" on sketch. From E which is 660 ft east from the section corner I ran South (same declination) 660 feet to "F" being the center point of the Northwest Quarter of the Northwest Quarter of Section Twenty-Six in Twp 20 N. Range 26 E. where I set stake to mark the site of well to be known as Gambrel No. 3..

I certify that the above is a correct transcript of field notes of survey made under my direction in the field for Kelly, Moore & Rader on Oct 3 1955. Witness my hand this 10 day of Oct. 1955.
