- 1) We propose to drill through the basalt and set conductor casing, then drill to the 604' where gas was encountered in the Mora Ranch #3.
- 2) If water is encountered as was the case in Mora Ranch #3, six and five eighths casing will be set and cement circulated to surface to shut off water flow. Gas will be tested.
- 3) Well will then be drilled through Niobrara to the greenhorn unless additional water makes further drilling impractical. If gas is encountered in greenhorn as well as Niobrara an additional string of pipe will be run to produce greenhorn unless Commission authorizes commingling.

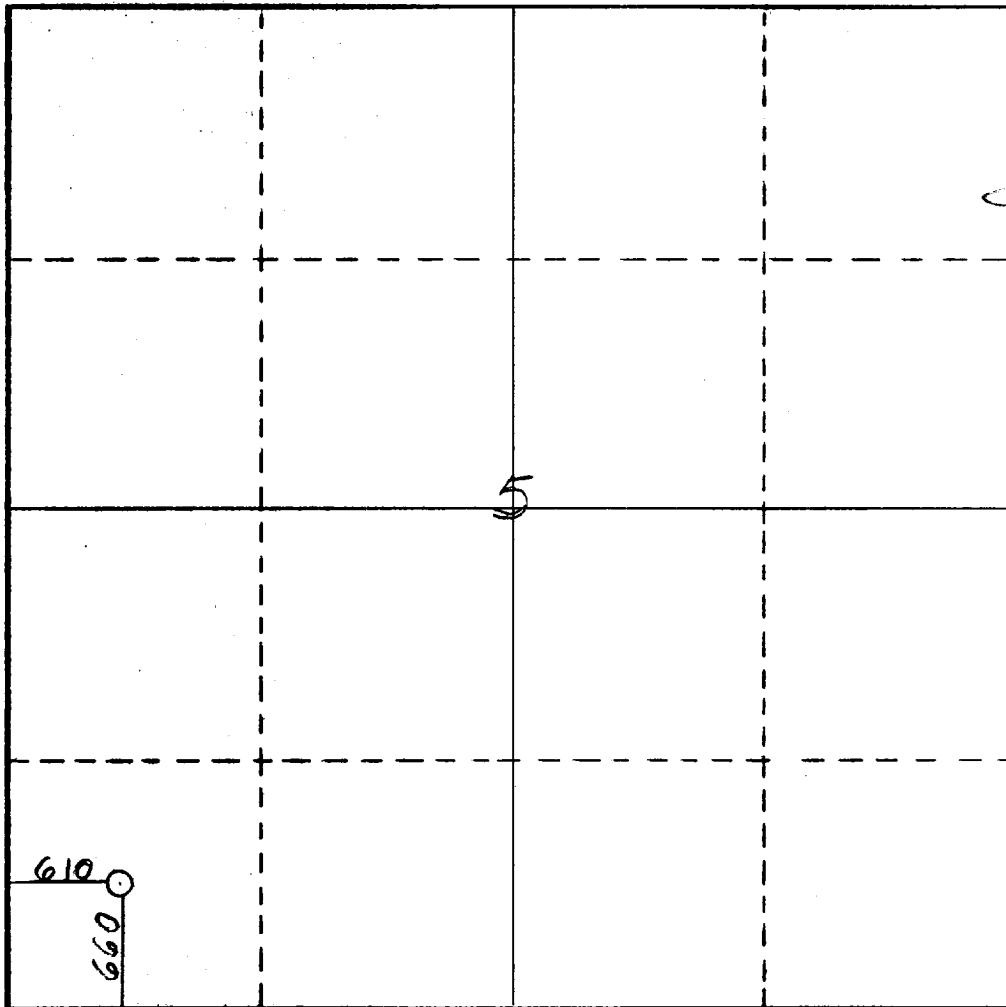
