On April 21, 1978, Panhandle Pluggers, Inc. of Pampa, Texas 79065, plugged & abandoned U.S. Frigidice - Well # 1, in Mora County. The procedure used was as follows:
30 sks. of cement with 4% gel, pumped from 1584' to 1410'. Then hole was loaded with mud, to 950' and 50 sks. with 4% gel was then pumped into well, from 950' to 750'. Then hole was loaded to 100' and 10 sks. cement with 4% gel was pumped from 100' to 50'. Then pumped mud in hole to 10' & 5 sks. cement was put in from 10' to 0'. Then a 4" x 4" marker was placed in top of well. Completion date - April 21, 1978
