FULL DETAILS OF PROPOSED PLAN OF WORK

(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

In accordance with verbal instructions received from Mr. J. E. Kaptana, the No. 1 Ft. Union well is to be plugged and abandoned as follows:

1. Fill hole from T.D. 1070' up to surface with heavy mud.
2. Set cement plug across water zone from 3425' up to 3490' 35' 10' SXS
3. Set cement plug across CO₂ and water zone from 2395' up to 2330' 65' 10' SXS
4. Set cement plug across CO₂ zone from 1936' up to 1966' 20' 5' SXS
5. Set cement plug from 1435' up to 1425' across casing shoe and up into the 8 5/8" casing 10' 3' SXS
6. In addition it is planned to set a steel plug at 1010' with a 20' cement plug on top and to perforate a fresh water zone at 884' to 896' and from 954' to 966' in order to make a water well.
7. Location to be cleaned up and restored to good condition.
