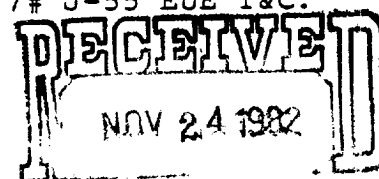

Drill to 1000' with fresh water mud and set 1000' of 4 1/2" casing 9.5# or 10.5# J-55 ST&C for surface pipe. Cement with 300 sacks of class "H" cement to surface. Test well. If well productive, run 900' of 2 3/8" tubing 4.7# J-55 EUE T&C. IF nonproductive, plug and abandon.

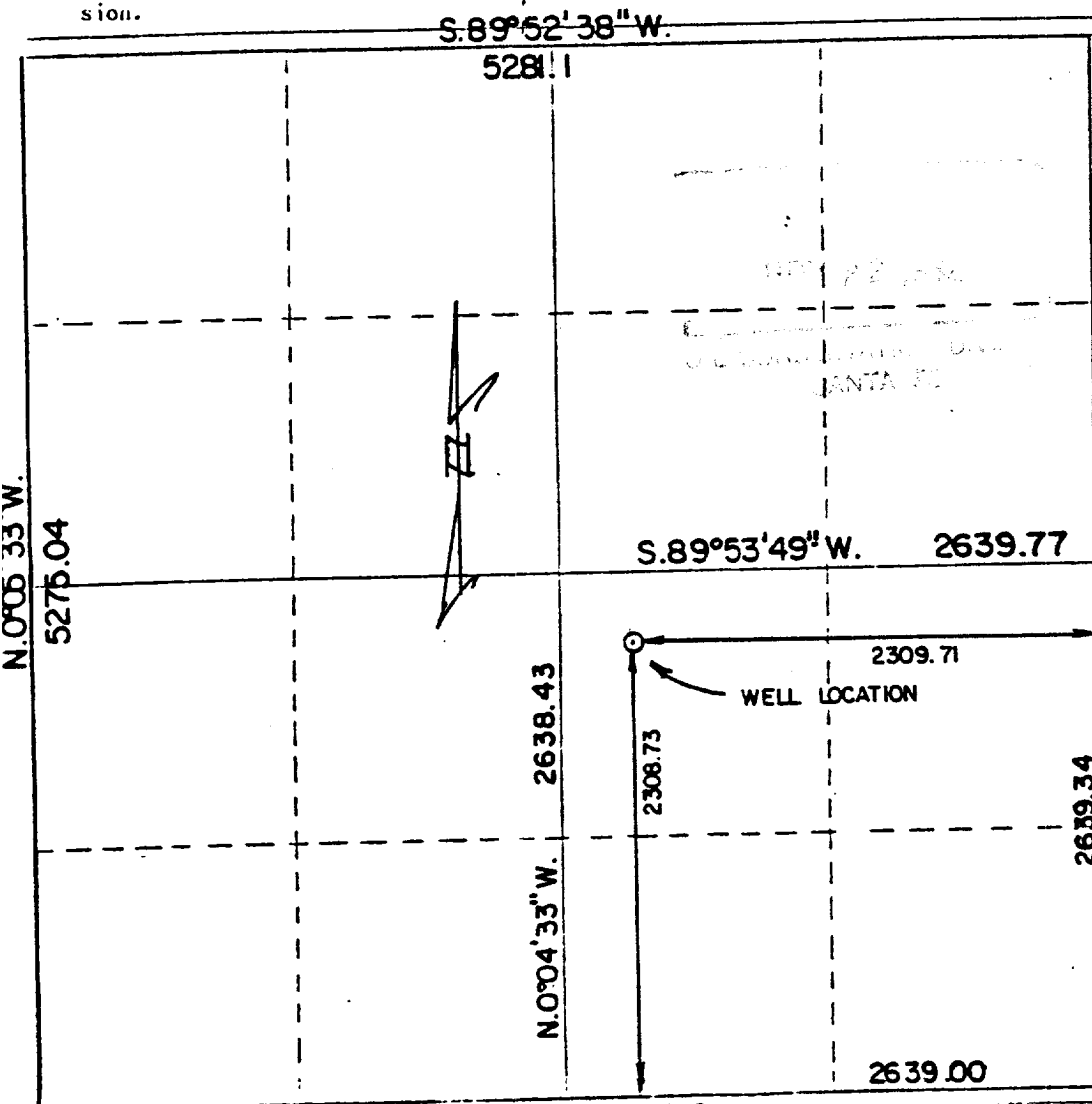
