Plugged well as follows: Geo-Source Wireline set CIBP at 4860' and capped w/30' cement on 5-22-84.

Cut casing at 2400'. Attempted to pull casing unsuccessfully. Obtained verbal approval from Roy Johnson, NMOCD, Santa Fe, 8:00 AM 5-23-84 and then pumped 150 sacks Class "C" 3% CaCl₂ followed with 450 sacks Class "C" 2% CaCl₂ cement down casing and out cut at 2400'. Reached squeeze pressure of 1700 psi. Cut staring flange off 13-3/8" and install dry hole marker.

Well plugged and abandoned 5-23-84.
