On 11-15-84 Co2 in Action Rig 16 supdded a 12 1/4" hole and drilled to a total depth of 730 ft. On 11-16-84 ran and set 9-5/8" casing at 730 ft. Cemented with 390 sacks Class H cement with additives. Bump plug with 700 PSI at 9:53 pm on 11-16-84. Circulated 52 sacks to reserve pit. Wait on cement for 12 hours. On 11-20-84 ran and set 7" casing at 2811 ft. Cemented with 1200 sacks Class H cement with additives. Plugged down at 8:15pm on 11-20-84. Rig released 11:15pm on 11-20-84.
