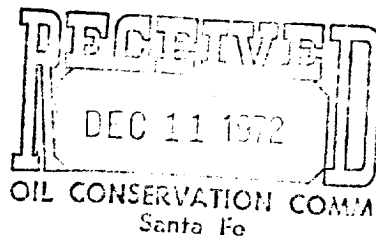

This well was temporarily shut-in as reported 9/21/71. Casing (1 1/2") is cemented at 4941'. Well was not tested for completion and was given no stimulation treatment. Operator now proposes to re-enter well and test and evaluate horizons that seem worthy of testing and evaluation and completion if tests indicate feasibility of completion as a producer of oil or gas or Co2 gas; if not, well to be plugged and abandoned.

Bond of former operator, Puretex Oil Company, is to be released and new Bond furnished by new operator, Zetco Petroleum Co. Inc.
