A cement plug was run from T.D. 4932' to 4780' all of the casing was left in the hole and was bridged at 150' and filled with cement to the surface. Five sacks of cement was put in the annulus between the surface casing and long string. The regulation marker was set and the location cleared.

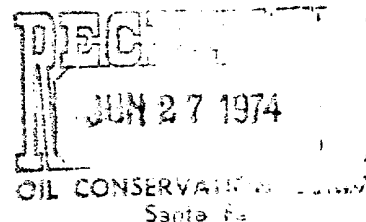

Gentlemen:

On June 6, 1974, I inspected the locations of wells drilled as oil/gas tests on the Chappell-Spade properties about seven miles northwest of Tucumcari, New Mexico. One of these locations did not appear to be in a very good condition, as the site was not level and there were some remnants of rig timbers scattered about. There was also a spool of drilling line (steel cable) and a truck mounted workover rig nearby. I did not detect anything which might cause injury to livestock however. Since the well has been officially abandoned since October of last year, we are anxious to close the file on this location. Noticing that some vegetation has begun encroachment upon the well site, I am wondering if you prefer that the location not be disturbed further. If so, we will approve the abandonment. On the other hand, if you wish for additional clearing and levelling, this office will attempt to have the operator comply.

The location discussed herein is identified as follows:

Zetco Petroleum Company, Inc., No. 1 Chappell, 1020' from the South line and 548' from the East line of Section 13, Township 12 North, Range 29 East.

Please advise this office concerning your desires in the subject matter. Thank you.
