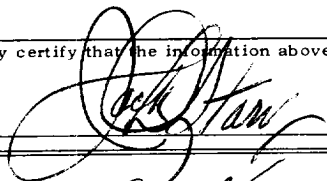

The captioned well was plugged and abandoned 11-20-71 as per instructions of the NMOCC. The well was first filled with heavy 9.8# mud-laden fluid. A 100 foot cement plug was spotted at 175 feet bringing the cement 50 feet up into the 125 feet of 8-5/8" surface casing left in the hole. The surface casing was bridged at 15 feet from the top with tightly rolled mud sacks and filled with cement, leaving room for the marker. The marker was prepared but not set at this time because of rig clearance. The rig must be off of the hole first and the weather was such that it could not be moved. A subsequent report will be filed when the marker is set and the location cleared to the satisfaction of the land owner.
