Well was spudded on 3-21-81. A 11' hole was drilled and 382' of 8-5/8" 24# surface casing was set with 275 sacks of type H cement, blended with 8 sacks of 3% cc. T.D. was reached on 4-5-82 and long string, 5540' of 4-1/2", 9-1/2#, K-55 was run with 1350 sacks of 50/50 POZ.

Well is temporary abandoned pending title clearance litigation and possible completion attempt.
