We propose to drill with air if possible, if not we will use fresh water mud. We will drill to 300 feet and set 7" casing at 300 feet. We will then drill to 2100 feet and if we think we have a producer, we will set 4 1/2" casing at 2100 feet. We will circulate cement to the surface on both strings of pipe. If we don't have a producer, we will plug the well as instructed - leaving the 7" casing in place.
